



2021 Pet Appreciation Week Giveaway Terms + Conditions

1. ELIGIBILITY: This Sweepstakes is open only to legal residents of the Continental United States (i.e., excluding Hawaii, Alaska, Puerto Rico, and the U.S. Virgin Islands) who are 18 years of age or older ("Eligible Participants").
